PERMISSION FOR PRIVATE PURCHASE OF MATERIAL TO THE CONSUMERS FOR NEW CONNECTION OR EXTENSION OF LOAD ETC.

Power Division has been directed by the Federal Cabinet to ensure that the DISCOs shall allow consumers to purchase cable, transformers, poles, etc. from prequalified/registered companies at the time of applying for new connection or extension of sanctioned load. In order to implement directions of the Federal Cabinet in true letter & spirit, the following actions/ steps are proposed for private purchase of material:

- 1. DISCO shall pre-qualify manufacturers for an appropriate duration on the basis of technical qualification / capability and prices of items in line with PPRA rules. List of qualified manufacturers and their contacts shall be displayed on DISCO website.
- 2. Each DISCO to ensure that consumer shall have the option to apply online for new connection or extension of load. The online application facility shall be developed, implemented and monitored by PITC for all DISCOs. The online facility should have the field for auto selecting the corresponding office of the load sanctioning authority by creating additional fields of load requirement and nearby electricity bill reference for auto selection of load sanctioning authority. The printout of the finalized application will bear name & contact number of the load sanctioning authority and bar code / QR code. As soon as a complete application is submitted, a system generated SMS will go to the load sanctioning authority and concerned SDO conveying them submission of application and last date for issuance of Demand Notice. Every stage of the application process shall be logged by the system and the applicant, load sanctioning authority and concerned SDO will have access to track the application.
- 3. Load sanctioning authority shall ensure preparation of estimate and approve the case of new connection or extension of load and issue demand notice to the applicant in specified period as mentioned in NEPRA Consumers Service Manual (CSM). The Demand Notice shall clearly mention items available with DISCOs and those to be purchased directly by the consumer. System generated NOC number will be issued for private purchase of material. Load sanctioning authority shall upload Demand Notice and NOC for private purchase of material on the website and system will generate SMS to the applicant for downloading. / collecting demand notice (/NOC) and make payment to any of the prequalified firm or to the DISCO as the case may be within thirty (30) days. The Demand Notice (DN) shall expire after thirty (30) days if payment is not made by the applicant.
- 4. After payment of Demand Notice, the load sanctioning authority will be responsible to get the material from Material Management Directorate within one week through SDO concerned after completing all departmental formalities.
- 5. In-charge of Material Management Directorate along with load sanctioning authority shall be responsible for release of material.

- 6. In case of non-availability of material in the respective DISCO's stores, the consumer will make payment to DISCOs' approved supplier/ manufacturers, as per pre-qualified price available on DISCOs' Websites
- 7. The supplier shall bear full responsibility for supplying quality material as per PEPCO/NTDCL/WAPDA approved specifications directly to the Directorate of Material Management within 3 days.
- 8. Privately procured material shall be inspected by Inspection) PEPCO and DISCO's representatives. PEPCO/NTDCL/WAPDA specifications to be strictly followed in this regard.
- 9. Inspection charges for the material to be inspected shall be borne by the consumer as per practice already in vogue and shall be clearly mentioned in the NOC.
- 10. The equipment, purchased directly by applicant from the manufacture, will not be handed over to applicant. On production of invoice paid by the applicant, the DISCOs representative will lift the material from manufacturing place.
- 11. Privately procured distribution transformers will bear the following markings punched/embossed on identification plate which is permanently welded on tank wall:
 - Name of concerned DISCO
 - Name of manufacturer and purchaser
 - System generated 'NOC number'
 - Serial No. and capacity of distribution transformers
 - Month/Year of manufacturing

Name plate will be provided separately containing all of the information as per standard specification.

- 12. Privately procured energy meters will bear the following information on its name plate:
 - Name of concerned DISCO
 - Private Purchase
 - Name of manufacturer and purchaser
 - QR code
 - System generated 'NOC number'
 - Month/Year of manufacturing
 - Other information as per standard specification
- 13. For privately procured poles/structures, following markings will be embossed with letters /figures at accessible, readable locations:
 - Name of concerned DISCO
 - Name of consumer & manufacturer
 - Date of manufacture
 - System generated 'NOC number'
 - Other information as per standard specification.

- 14. For privately procured cables, following markings will be embossed/printed on cable after every one meter:
 - Name of concerned DISCO
 - Size of cable
 - Name of manufacturer
 - Year of manufacture
 - System generated 'NOC number'
 - Other information as per standard specification
- 15. Following markings will be embossed/printed /engraved on the remaining material:
 - Name of concerned DISCO
 - Name of consumer and manufacturers
 - Date of manufacture
 - System generated 'NOC number'
 - Other information as per standard specification
- 16. Any other instruction may be added to safe guard the interest of DISCO.
- 17.SOP for private purchase of material shall be got approved from BoDs of respective DISCOs before implementation.
